The mission of the Waterbird Society is to foster the study, management, and conservation of the world's aquatic birds. The Society's primary goals are to: (1) promote basic and applied research on waterbirds and their habitats; (2) foster science-based waterbird conservation globally; and (3) enhance communication and education at all levels among professionals, policy makers, and citizens by publishing an international peer-reviewed journal, hosting scientific meetings, and facilitating other outreach activities.

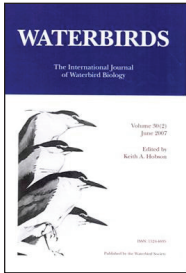

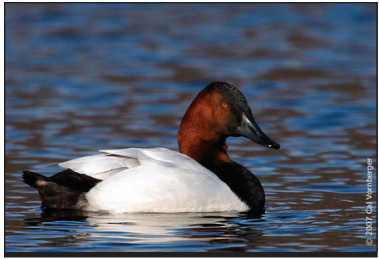

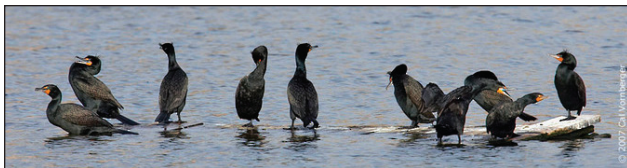

Annual Meeting

The Waterbird Society hosts an annual meeting for members and other interested researchers to present findings of their research and to interact with other professionals and students from around the world. Meetings typically draw up to 300 participants, and have been held at locations in North and South America, Europe, and Asia.

The Waterbird Society has played an important role in the development of conservation plans for the Americas by providing a venue for discussion and a means to bring together individuals from around the world who are studying similar issues.



Awards

The Waterbird Society presents several awards to individuals for outstanding contributions to waterbird science, exemplary service to the Society, and to students for excellence in presentations. Student grants are offered for travel to annual meetings. The Kushlan and Nisbet Research Awards provide funds for research on waterbirds.
